(vi) **Institutional set-up for liquidity risk management**

The Board of Directors of the Company has constituted the Audit & Asset Liability Management Committee and the Risk Management Committee. The Audit & Asset Liability Management Committee is supported by Asset Liability Management Support Group to analyse, monitor and report the liquidity risk profile to the Audit & Asset Liability Management Committee.

The Audit & Asset Liability Management Committee reviews the liquidity risk management, funding and capital planning, analysing different scenarios and preparation of contingency plans. Further, the Risk Management Committee monitors and measures the risk profile of the Company.

The Company manages liquidity risk in accordance with the Company's Asset Liability Management Policy. The Company manages liquidity risk by maintaining sufficient cash surplus and by keeping adequate amount of committed credit lines to meet its repayment obligations.
